#### **March 2018**

#### 1. NRCS Conservation Planning Boot Camp

NRCS Conservation Planning Boot Camp is a three-week, intensive training course for technical employees that covers current conservation planning policy, procedures, and guidelines as outlined in the National Planning Procedures Handbook.

Each year for the next five years, 75 conservation district employees will have the opportunity to participate in this Lincoln, Nebraska-based program. District participants are trained in and out of the classroom – right alongside NRCS field staff – in the skills necessary for developing and implementing comprehensive conservation plans. District participation in the course ensures conservation technical assistance is provided to local landowners and operators in a consistent manner nationwide.

#### 3. 2019 Water Quality & Conservation Grant

The New Mexico Soil and Water Conservation Commission (SWCC) annually receive a legislative appropriation from the State of New Mexico to be used for special projects relating to water quality and conservation. These funds are awarded by the SWCC through the Water Quality and Conservation (WQ&C) Grant Program. The goal of the grant program is to promote the health of New Mexico's watersheds and conserve the water resources they produce. A limited number of projects addressing one or more of the following areas will be funded over the next fiscal year:

- 1. Watershed Improvement/Management
- 2. Irrigation Efficiency
- 3. Riparian Restoration
- 4. Natural Resource Information and Education
- 5. Ground Water Protection/Conservation
- 6. Noxious Weeds

All proposals are due **Friday, April 6th by 5:00 pm**. The proposal needs to be in Microsoft Word formatted version and **emailed** to: **swcc@nmda.nmsu.edu**. **Faxed copies will not be accepted.** The application is attached.

#### 4. DFA Local Government Budget Management System Rollout Postponed

At the Soil and Water Conservation District Operation Training in Moriarty in December, the Department of Finance Administration (DFA) announced the rollout of a new system for using the Local Government Division's standard chart of accounts rather than the district's internal chart of accounts. At that time they announced that all districts would have to use the new system by June 1, 2018. Please refer to the message below that was distributed by DFA. At this time, there's no longer a definite date by which the districts will have to be using the new system.

Local Government Budget Management System (LGBMS) implementation for special districts has been delayed and special districts are NOT required to "go live" on June 1, 2018. The special district feedback received by the DFA Local Government Division (LGD) highlights the need for chart of account changes and small group trainings geared towards particular special district types. Unfortunately, LGD currently does not have the staff or time to meet these requests.

Counties and municipalities will "go live" on June 1, 2018 and the experience gained from that endeavor will help LGD to further improve LGBMS before bringing special districts onboard. At this time, there is no definite "go live" date for special districts. However, after July 1, 2018, we will focus on working with groups of special districts so that we can phase-

in LGBMS implementation. Rest assured that LGD is committed to working closely with special districts in order to make the transition to LGBMS as smooth as possible.

Those of you who are currently in the LGBMS pilot group will continue to submit on LGBMS, test system enhancements, and provide your feedback for improving the system.

If your special district is 100% complete with the crosswalk from your internal chart of accounts (COA) to the LGD standard COA, or you have adopted the LGD standard COA as your internal COA, and you are interested in early access to LGBMS, please let DFA know so that they can send you further instructions.

The initial inspection during our scheduled program will be at NO CHARGE provided the request is received by the March 31, 2017 deadline. However, a fee will be charged based on the current Fees for Weights and Measures Services schedule if:

- the request for inspection is received after the March 31<sup>st</sup> deadline.
- you need your scale inspected before the time we have it scheduled.
- you request an additional inspection in the same calendar year.
- re-inspection is requested of a scale previously inspected during 2017 with results as "No Test" because of a dirty beam box/house with excessive rodent nests or droppings.
- re-inspection is requested of a scale that was previously inspected and rejected during inspection year 2017.
- you are unable to have scale ready for inspection when inspector is in the area.

If you have sold or leased your property, please forward this information to the new owner/operator or have the new owner notify this office. If you know of anyone with scales that may need to be inspected, please ask them to contact the department for information on our Livestock Scale Inspection Program.

#### 11. NMSU Certified Calf Program

Value added programs are a marketing tool which allow cattle producers to bring more dollars to their bottom line. At the basic level, value added programs assure buyers the calves received some type of vaccination / health protocol.

Marketing opportunities, such as grass-fed, all natural, and export, require age and source verification. For age and source verification, cattle require an official "840" EID tag which is an official USDA tag for animal traceability.

In an effort to promote additional marketing options for New Mexico cattle producers, NMSU offers two calf certification programs, **ACES High** and **ACES High**+.

**Online Enrollment & Certification** | **Beginning February 1, 2018** producers are encouraged to enroll online and contact their local County Extension Office to have calves certified by the County Agriculture Agent. Extension Offices are also available to assist with the enrollment process.

NMSU CES will also inform all regional sale barns and other cattle markets about the ACES High and ACES High+ programs in an effort to gain program recognition throughout numerous marketing venues.

NMSU CES will host certified sales at area sale barns where a segment of the sale will be dedicated to ACES High or High+ calves. NMSU CES will also help facilitate advertising of these sales. Participation is optional.

There are no guarantees of increased value by participating in these programs. Traditionally, this type of value-added program results in \$6-7 / cwt premiums.

Funding is intended to directly benefit communities that may be impacted by wildland fire initiating from or spreading to BLM public land. The 2018-2019 Wildfire Risk Reduction Grant Program grant cycle will give priority to applicants who request funding for outreach and education projects (i.e. Fire Adaptive Communities, Ready, Set, Go Program) that encourage reducing wildfire risk on non-federal lands and can show a direct benefit to BLM lands. Requirements for New Mexico State Forestry CWPP updates are included with the program information. A limited number of hazardous fuel reduction projects will also be considered. Please review all materials thoroughly and complete the submission checklist before submitting your application packet. Incomplete applications will not be accepted. *All applications must be received by the New Mexico Association of Counties office by 5:00 pm on March 30, 2018 and can be submitted electronically to awebb@nmcounties.org.*
