Special Meeting – 3 Days Prior

Emergency Meeting – 24 Hours Prior

## 1. Planning a Referendum?

Districts wishing to hold referendums need to obtain approval of the SWCC with sufficient lead time for county clerks to be notified in a timely manner. Referendums require that county clerks be notified at least 120 days prior to the referendum. Boundary modification actions may also require petitions signed by landowners or registered voters prior to SWCC approval.

SWCDs preparing for a referendum in spring of 2018 should obtain any required petitions, pass a resolution of the board, and submit the documentation to the SWCC for approval in the fall of 2017.

#### 3. NMACD Annual Meeting

You can also cc your Specialist and SWCC Region Commissioner. If the SWCC does not have record of these documents when the FY18 Point System Worksheets are scored, your Specialist will not be able to award points for that item.

## 5. Soil and Water Conservation District Operations Funding

Each year the legislature provides appropriations for soil and water conservation district operations. The appropriation available for distribution this year is \$629,410.00. Due to recent budget cuts and revenue forecasts, NMDA will withhold from disbursement ten percent of the funds, approximately \$62,941.00, herein until after the 2018 regular legislative session. These funds are general appropriations which are subject to budget reduction.

The funding allocation is determined annually by a point system under which districts, depending on how active they are, receive a certain dollar amount per point earned. The first

SWCD operations checks have been sent. If there are questions regarding the district's funding amount or if the district has not yet received their operation check, please contact your NMDA Specialist.

#### 6. WUI Grant Program

The NM Forestry Division is seeking applications for planning and implementation of hazardous fuels mitigation projects that will reduce fire threat in Wildland Urban Interface (WUI) areas. If you have received the draft legal description and maps from NMDA, NMDA is waiting for the Board's approval. Please email the SWCC and your NMDA Specialist the signed resolution once the board approves the updated legal description and map. This must be done by the Board's September meeting so that it is on the SWCC's agenda for their next meeting in October.

Whatever stage your SWCD is at in this process, please try to complete the requested information from NMDA as quickly as possible. NMDA is trying to get everything finalized no later than the end of September. If you have questions regarding where your description is in the process, please contact your NMDA Specialist.

## 8. RFP Training

The RFP training is an intensive, "hands-on" exercise based class designed to teach students how to manage a RFP based procurement from inception to completion of the protest period. This class is detailed in nature and DOES address specific day-to-day operating procedures necessary to manage a RFP based procurement to a successful completion. Following a RFP based procurement roughly chronologically, the class includes developing the initial requirements, developing the RFP document itself (with specific focus on the requirements and evaluation criteria), issuing the RFP, managing proposals received, evaluating proposals

received, selecting finalists and the "Best and Final Offer" process, awarding the contract(s), managing the protest process and properly documenting everything to comply with all legal and practical requirements. The next three day class is from: September 19-21 and November 7-9.

The Pulling Together Initiative program is inviting applications for competitive grant funding to promote the conservation of natural habitats by preventing, managing or eradicating invasive and noxious plant species. In 2017, the program will award grants to develop or advance Cooperative Weed Management Areas (CWMAs) and Cooperative Invasive Species Management Areas (CISMAs).

Approximately \$850,000 is expected to be available for grant awards in 2017. The program is a partnership between the National Fish and Wildlife Foundation, the Bureau of Land Management, the U.S. Fish and Wildlife Service, and the U.S. Forest Service. NMDA encourages all SWCDs to stay active in the Forest Plan Revision process for all five national forests. We also encourage SWCDs to provide information as requested to make sure that SWCD information is included in the process.

## 12. New Mexico State Forestry Conservation Seedling Program

Orders for the Fall 2017 Conservation Seedling Sale will be taken starting July 10, 2017. Distribution will be September 12, 2017 through October 13, 2017. For more than forty years, the Division has offered low-cost seedlings to landowners to plant for reforestation, erosion control, windbreaks, or Christmas tree plantations. Since 1960, more than four million trees have been planted throughout New Mexico that were purchased through this program.

The Forestry Division offers over sixty different species for sale over the course of the fall and spring sales. These seedlings are sold in small containers, large containers, and bare root. Please note all containerized species are offered in the fall and bare root species and any remaining containerized species are offered in the spring. It has been shown that fall is a highly successful time to plant containerized seedlings. Plants have time to establish roots over the winter while dormant before putting on top growth in the spring and as an added

bonus the weather is better for planting! Select your shipping or pickup date so that you can plant your seedlings five to six weeks before your area of the state starts having hard freeze days. # 19. Request for Applications for Invasive Plant Management in Forested Areas

The New Mexico Energy, Minerals and Natural Resources Department, Forestry Division is seeking applications to address management of invasive plants on state, private, and public non-federal lands from Cooperative Weed Management Areas (CWMAs) where noxious weeds threaten forested acres. Eligible applicants are non-federal governmental entities involved with a CWMA, including tribes and pueblos (as long as other federal money is not involved). Successful applicants shall be required to provide 50% matching funds.

This Request for Application's (RFA) primary goal is to increase local capacity to manage and prevent invasions of noxious weeds in forested areas. The U.S. Department of Agriculture, Forest Service (Forest Service) has provided these funds specifically to address areas where invasive plants threaten forested acres. Projects must emphasize prevention and treatment of invasive plants. Projects that do not specifically target invasive plants threatening forested areas are not eligible for this funding. Locally-driven CWMAs have been shown to be the best vehicles for implementing weed management programs. Therefore, this program emphasizes the use of existing CWMAs or the creation of new CWMAs.
