Report to Congress

A new report has been developed proposing a 2017 Reorganization of the Dept. of Agriculture to establish an Under Secretary for Trade and Foreign Agricultural Affairs. Reasoning is to meet the challenge of advancing Ag. Trade, improving service delivery to Ag. Producers, and addressing the needs of Rural America. In addition, USDA is proposing to create a new department for Farm Production and Conservation (FPC); and realign the Farm Service Agency (FSA), NRCS, and RMA (Risk Management Agency) under this new department. Forest Service will continue to be under the USDA umbrella under Natural Resources and Environment. This report does not address a reduction in force. I have included a Current and Proposed Reorganization flow chart.

Conservation Stewardship Program (CSP)

 <u>2017 Conservation Stewardship Program</u> – May 26, 2017 - Inventories on all CSP applications must be completed. Applications pre-approved on June 9, 2017 and 100% funds obligated by September 11, 2017.

<u>RCPP-Regional Conservation Partnership Program</u>

<u>2017 RCPP Funded Projects</u> – Spoke to Programs folks and they are still working on completing the Agreement with the Regional Teams. Timeframe to obligate those funds looks like September of 2017. Currently have 2 applications for the range improvements.

EQIP ACTIVE CONTRACTS

Currently have 40 EQIP contracts, 3-RCPP Contracts, 9-CSP contracts, 70-CTA requests, that all my field offices are servicing for completion. This is the time of year my staff are out in the field certifying practices, addressing new request, meeting with contractors, attending outreach/training events.
